## Costume Payments

Yeah! It's that exciting time of the year again when teachers are picking music, starting dances and finding the most wonderful costumes imaginable for our year end recital. Costume payments for all recreational classes of \$40 per dance in the recital (not per class) are due on October 16<sup>th</sup>! If your dancer has three dances in the recital, \$120 will be due. The preferred payment is via cash or check. If not paid by check or cash on or before Oct. 16<sup>th</sup> the 1<sup>st</sup> costume payment will be pulled from your billing info on file with a 3% convenience fee. Note: The \$40/costume is approximately half of the costume payment and the remainder will be due Nov. 15<sup>th</sup>. *Performing and Competition company dancers will have their separate deposits due Oct., Nov. and Dec. 15<sup>th</sup>.*
